SUBJECT: Office Closures for Staff Meetings

Administrative Rule 18(a) ¹ allows courts to close for up to one hour per week for staff meetings and training if prior approval is obtained from both the administrative director and the presiding judge. Advance notice of the closure must also be posted in the places designated in the rule.

The courts listed below have received permission to close their clerk's offices at the listed times each week. In some cases, the closure is limited to certain parts of the clerk's office and may not, for example, include the front counter.

¹ Rule 18(a) states:

Superior and District Courts -- When Open for Business. The superior and district courts shall be open for the transaction of business during business hours from 8:00 a.m. until 4:30 p.m. on all days except judicial holidays and Saturdays; provided, however, that the courts may at any time extend these hours as circumstances may require or as may be ordered by the presiding judge. The presiding judge may authorize the closure of an office for up to one hour per week for staff meetings and training under a plan approved by the administrative director. The clerk of court must give advance notice of the closure by posting notices on the court's bulletin board, on the doors of the courthouse, and in the clerk's office.
