**ORDER SUSPENDING JURY TRIAL PROCEEDINGS IN
THE SECOND JUDICIAL DISTRICT**

On September 20, 2021, the Chief Justice of the Alaska Supreme Court issued Order No. 8333¹. This order requires presumptive two-week suspension of jury trials in any court location when the number of reported cases by DHSS per 100,000 over the past 7 days reaches 100 or more.

As of November 1, 2021, DHSS 7-day case rate per 100,000 and local active cases in the Second Judicial District are as follows:

Given the 7-day case rate and pursuant to the authority granted to the presiding judge in Special Order of Chief Justice 8333, jury trial proceedings are suspended for the entire Second Judicial District from November 8-November 30, 2021. This suspension will be reviewed the week of November 22 to determine if an extension of this order is necessary. The time limit for preliminary examination under Alaska Criminal Rule 5(e), and time for trial under Alaska Criminal Rule 45(d) are tolled during this time and extended through December 30th.⁵
