## List A Felony PTRP Filing Locations When Sentencing Court Retains Jurisdiction

(Where Case Files Are Kept After Sentencing)

Petitions to revoke probation and probation-related motions must be filed in the sentencing court, unless supervision has been transferred to another court <u>because the defendant has moved</u> (see List B). The sentencing court is identified in the case number. If that court's case files are maintained in another court location after sentencing, the petition or motion must be filed where the files are kept. The following list shows the courts where felony case files are kept after sentencing.
