PRESIDING JUDGE ADMINISTRATIVE ORDER ESTABLISHING STATEWIDE PROCEDURES FOR TELEPHONIC PARTICIPATION IN CINA PROCEEDINGSⁱ

- 1. **Scope of Application.** This order, issued pursuant to CINA Rule 3(g) and Administrative Rule 46, governs telephonic participation in CINA proceedings in all judicial districts of the State of Alaska.
- 2. Procedures When Case Participants Are Not Present at the Court Location. Any case participants, including out-of-home care providers, grandparents, tribes, parties, counsel, witnesses, or the judge, who are not physically present at the court location may participate telephonically in any CINA hearing without court approval or prior notice. Participants are encouraged nonetheless to provide prior notice of their intent to participate by telephone.
- 3. **Procedures When Case Participants Are Present at the Court Location**. Case participants who are physically present at the court location may participate by telephone in any CINA hearing with court approval.
 - 4. **General Conference Call Procedures.** In all CINA cases,
 - (a) The court will include its conference number and instructions for how to call-in on its hearing notices and pretrial orders. The information will also be available from the clerk at the court location where the matter is being heard.
 - (b) At the start of every hearing, the in-court clerk will open a conference line and inquire as to the identity of the persons on the line. The in-court clerk will disconnect the conference line when the hearing ends. The court may disconnect

the conference line prior to the end of the hearing if no caller is on the line 30 minutes after the hearing started. During the hearing the court may, in its discretion, call a case participant who fails to appear.
