IT IS ORDERED:

That Rules Governing the Administration of All Courts and Rule 73(a) of the Rules of Civil Procedure are amended as follows:

Rule 27(c), Rules of Administration, is amended by deleting the phrase "Saturday afternoons" and substituting in lieu thereof the word "Saturdays".

Rule 32(c), Rules of Administration, is amended by deleting the phrase "Saturday afternoons" and substituting in lieu thereof the word "Saturdays".

Rule 32(d), Rules of Administration, is amended by deleting the phrase "Saturday afternoons" and substituting in lieu thereof the word "Saturdays".

Rule 73(a), Rules of Civil Procedure, is amended by deleting the phrase "Saturday afternoons" and substituting in lieu thereof the word "Saturdays".

ADMINISTRATIVE OFFICE BULLETIN

SUBJECT: Saturday Closing of Court Offices

The supreme court has approved termination of the policy that has required clerks' offices, recording offices, and other court offices to be open to the public on Saturday mornings. The effective date of the court's Order No. 77, which makes the policy change, is July 30, 1965, and all court offices are therefore authorized to be closed on Saturdays commencing July 31, 1965.

To inform the public users of the offices of this change, notice should be posted on court bulletin boards for an appropriate length of time to the effect that henceforth the offices will be closed on Saturdays.

It should be noted that this change does not affect the requirements of the criminal rules as to the availability of magistrates for arraignments and other procedures which must be performed within limited periods of time or on an emergency basis.
