Revising Rule 31, Rules Governing
the Administration of all Courts.

IT IS ORDERED:

That Rule 31 of the Rules Governing the Administration of all
Courts be amended to read as follows:

(a) District Judges. The district court in each judicial
district shall have the number of judges as set forth below:

First Judicial District - 5

Second Judicial District - 1

Third Judicial District - 7

Fourth Judicial District - 4

The number of district judges may be changed from time to time by
the supreme court as circumstances require.

(b) Magistrates. Magistrates shall be appointed to serve at
the places indicated below:
