Administrative Order 3AN-AO-23-02

**Transfer of Cases from Judge Eric Aarseth to Judge Peter R. Ramgren**

1. Effective February 1, 2023, **all open** cases currently assigned to Judge Eric Aarseth will be reassigned to Judge Peter R. Ramgren.
2. Notice of peremptory disqualification for cases reassigned to Judge Peter Ramgren under this order must be filed on or before **January 31, 2023** except as provided by Civil Rule 42(c)(4) and Criminal Rule 25(d)(5). Each party is allowed one peremptory change of judge during the life of a case. This administrative order does not grant any party an additional right to peremptorily challenge a judge.
3. It is the responsibility of all Third District law firms and attorneys to notify any associate counsel or opposing counsel who are outside the Third Judicial District or the State of Alaska of the foregoing reassignments for purposes of peremptory challenges.
4. Effective February 1, 2023 Judge Peter Ramgren's current civil caseload will be transferred to Not Assigned 3AN06 except for the following cases:
